Advanced Life Support Courses

Advanced Provider Courses

The advanced provider courses are intended for health care providers (e.g., physicians, nurses, paramedics, respiratory therapists, pharmacists, and allied health professionals) whose daily occupation requires advanced life support proficiency.

The American Heart Association (AHA) strongly promotes knowledge and proficiency in basic life support (BLS), ACLS and PALS, and has developed instructional materials for this purpose. Use of these materials in an educational course does not represent course sponsorship by the AHA. Any fees charged for such a course, except for a portion of fees needed for AHA course materials, do not represent income to the AHA.

Pre-course Preparation

- All class participants must register at least 48 hours in advance of their chosen class date. Anyone who is not registered in advance will not be permitted to attend the class.
- Class participants must have a current provider status in ACLS/PALS in order to register for a retraining course. If your provider status has expired, you must take a full train class.
- Participants are expected to have mastered the skills of BLS before enrolling in the ACLS or PALS courses.
- Participants must complete a pre-test before taking an ACLS or PALS course.
