## PGY-1 Acute Care Pharmacy Residency

**ProMedica Flower Hospital** is part of ProMedica Health System (PHS), a locally owned, not-for-profit, health system located in Northwest Ohio and Southeast Michigan serving 27 counties with 13 hospitals, numerous health care centers and has an extensive array of specialties. Flower Hospital is a 311-bed facility located in Sylvania, Ohio. Our campus includes emergency services, inpatient psychiatric services, obstetrics and gynecology, general community medicine, and outpatient surgical services. The Hickman Cancer Center – the region's leader in oncology services – is also located on the campus.

This ASHP-candidate PGY-1 program provides a comprehensive residency that will provide a structured educational experience in the provision of pharmaceutical care while allowing flexibility in design to meet the needs of the candidate. A stipend, health insurance, and time-off benefits are offered with this residency.
